Mister Car Wash® ("Sponsor") Teacher Appreciation Giveaway ("Contest") - Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

Contest begins on 4/3/2017 at 9:00 AM MST and ends on 5/1/2017 at 11:59pm MST ("Contest Period").

ELIGIBILITY: Contest is open to persons who are legal residents of, and physically located within, the 50 United States or D.C., age 18 or older at time of entry. Void where prohibited. TIMELINE:
