

# Mister Car Wash® Teacher Appreciation Contest

## Terms & Conditions

Car Wash Partners, Inc. dba Mister Car Wash® (“Sponsor”) will accept entries for the Teacher Appreciation Contest (“Contest”) in accordance with the “Terms and Conditions” set forth herein. By participating in Contest by submitting a Submission, defined below, each Entrant, defined below, agrees to abide and be bound by these Terms and Conditions.

**NO PURCHASE IS NECESSARY TO ENTER OR WIN:** No purchase is necessary to enter or win and a purchase will not increase your chances of winning or being selected.

**CONTEST DESCRIPTION:** Contest begins on February 26, 2018 at 12:00 AM MST and ends on April 2, 2018 at 11:59pm MST (“Contest Period”). Entrants can nominate a Teacher, defined below, that inspires others to shine for a chance to win a \$500 - \$1,000 grant and a one-year Unlimited Wash Club® Membership for the Teacher.

**HOW TO ENTER:** During the Contest Period, “Entrant” may visit <http://mistercarwash.com/teacher>, follow the directions provided thereon to complete the “Entry Form”, and submit the Entry Form (“Submission(s)”). In completing the Entry Form, Entrant will nominate a “Teacher”, as identified on the Entry Form, for consideration in Contest.

Limit of one (1) Submission per person “Submission Limit”. Any Submission received from any person in excess of the Submission Limit is void. Any Submission generated by script, macro, or other automated means are void and will not be considered for selection. A Submission must be received by Sponsor within the Contest Period to be valid.

**ELIGIBILITY:** Contest is open to persons who are legal residents of, and physically located within, the 50 United States or D.C., and age 18 or older at time of entry. Void where prohibited. Each selected Teacher (“Winner”) will be awarded one (1) Platinum Express Unlimited Wash Club® (“UWC”) membership for one year and one (1) grant of either five hundred dollars (\$500.00) or one thousand dollars (\$1,000.00) (collectively, “Prizes”), as determined by the Panel, defined below.

**SELECTION OF WINNER(S):** Every Submission received by Sponsor during the Contest Period will be scored by a panel of judges (“Panel”), which may include or be comprised solely of representatives of the Sponsor, based upon the following criteria and weighted accordingly:

- compelling nature of Teacher’s inspiring qualities (50%);

Every judge on the Panel will score each Submission using the same criteria set forth above. The decisions of the Panel will be final and binding on all matters relating to this Contest.
